I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Llanbadarn Fawr Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Register of councillors' interests

There is no register of councillors' interests on the Council's website. We recommend that the Council upload a declaration of councillors' interests to their website.

VAT reclaims

The Council has not reclaimed any VAT during 2023-24. We recommend that the Council reclaim VAT to increase their income.

Payments made before approval

Two payments were made before approval was obtained. Also, we failed to find evidence of approval for one of those payments within the minutes. We recommend that the Council approve all their payments within the minutes and make payments after they've been approved.

There are no further matters I wish to draw to the Council's attention.
